# FIND YOUR ELECTED OFFICIALS

Don't know who your elected officials are? Don't worry! The Illinois State Board of Elections' "Find My Elected Officials" page makes it easy to find them.

The first step is to visit **ilsenategop.org/find\_your\_lawmaker** and hit *"Click to Find My Elected Officials"* under the photo of the state. That will redirect you to an interactive map that allows you to enter your home address. Doing this will reveal all of your federal and state elected officials.

## HOW TO FILE A WITNESS SLIP

An important step that you can take as a resident and voter in this state is to make your stance on potential legislation known. You can do this in a number of ways, which starts with contacting your local legislator. In addition to reaching out to your legislator, you can also make your support or opposition to a specific bill known to all General Assembly members by visiting the General Assembly's official website and filing a witness slip. Check out this step-by-step guide on how to accomplish this sometimes-tricky task. 1. Go to the Illinois General Assembly Website at http://www.ilga.gov/.

2. Once there, look to the lower left, under Reports & Inquiry and click on GA Dashboard.

3. Next, select either **Senate or House tab** located under the State seal, then select Committee Hearings from the drop-down menu.

4. Next, select the chosen committee by clicking on the paper icon on the far right.

5. Next, choose a bill and look to the right. Under Witness Slips, there are two icons. Click on the pencil and paper icon to create your Witness Slip.

6. Fill out and submit witness slip.
